



PORTRAIT PHOTOGRAPHY CONTRACT

Thank you for choosing Kelly Photo & Design as your photographer! Please look at the following document and review all the details to understand and follow the expectations for KPD's photography package. You are agreeing to these terms when scheduling a session with KPD.

Payment

Half of the payment is due the day of the session. The other half of the payment is due within one week after the session date. You may choose to pay in full the day of the session. I will send an invoice with options on how to pay (methods include: check, cash, Venmo, and Pay Pal).

Timing

Session time is running during travel between locations and outfit changes. And in order to maximize lighting and my time, KPD policy is that the session time begins at the time agreed upon. This means that tardiness impacts total session time, unless it is to my fault. There is a \$25 fee for cancelling and a \$10 fee for rescheduling within 48 hours, unless it is weather related.

COVID Update: If any of the clients have symptoms or have been tested, cancellation and rescheduling is free.

Edits

You will receive your full-resolution digital album of edited photos within three weeks after the date on Google Drive. I vary my editing based on the lighting of that photo so you may notice style differences. You may request a flash drive (\$10 charge) in advance if you prefer that over a cloud format. You will have access to the Google folder for two months. The raw files will be deleted after two months, meaning you will have that much time to request any edit changes. I will keep the edited photos on my hard drive for one calendar year, but I encourage you to download all the files onto your own hard drive as soon as possible. Please contact me for technical difficulties.

I can rush edit for a \$10-20 charge depending on how soon. If you are interested in further editing, I can do teeth whitening, touch-ups, sharpened eyes, wrinkle-smoothing, and endless options for \$2/photo.

Printing

You have full printing and posting rights after you pay the full investment. I do offer high quality, hassle-free printing services, including photo books, prints, holiday cards, and more.
